



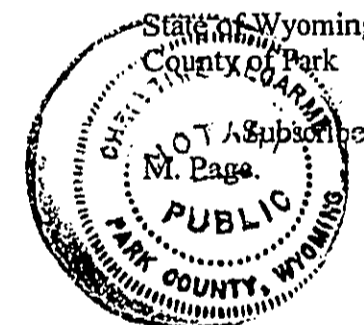
I, Francis M. Page, being of lawful age and first being duly sworn upon oath, state and depose as follows:


1. I am the Park County Engineer and Road & Bridge Supervisor for Park County, Wyoming.
2. My job duties include management and administration of the Engineering and Road & Bridge Departments, including the rural addressing policy.
3. The Plat of Cody Ranchettes is filed in the Park County Clerk's Office, Book C, Page 88.
4. The original Plat dated November 3, 1976 dedicates all streets within the Cody Ranchettes Subdivision to the use of the general public and names said roads on the Plat.
5. Prior to this date, the roads in this Subdivision had not been constructed.
6. As of this date, the owner and developer of the Cody Ranchettes Subdivision is Jeff Kruger, except for Lot 20, 21 and 22 which is owned by Mark S. & Sandra E. Thornburg.
7. Mr. Kruger and Mr. Thornburg have agreed to the road name changes.
8. Due to road name conflicts, the Rural Address Review Committee initiated change of the road names for the Cody Ranchettes Subdivision.
9. From this date forward the names of the roads will be as follows:
 - Shoshone Drive is changed to Partridge Lane
 - Meadowlark Drive is changed to Tanager Drive
 - Rolling Hills Drive remains unchanged.
